THE YORK WATER COMPANY ANNOUNCES 567th DIVIDEND

York, Pennsylvania, August 21, 2012: The York Water Company's (NASDAQ:YORW) President and CEO, Jeffrey R. Hines, announced that the Board of Directors at their August 20th meeting declared a quarterly dividend of \$0.1336 per share.

This is the 567th consecutive dividend paid by The York Water Company. York Water, which is the oldest investor owned utility in the nation, has paid dividends for 196 consecutive years beginning in 1816. This is believed to be the longest record of consecutive dividends in America. The dividend is payable October 15, 2012 to shareholders as of record date October 1, 2012.
